Subject: Approval of Requested Rate Adjustment for Solid Waste Rates

Dear Mr. Harrison:

The City of Camarillo has reviewed and approved your proposed request for an adjustment to the residential and commercial solid waste rates, pursuant to the conditions outlined in sections 12.3, 12.4 and 12.6 of the Agreement. The increase in the solid waste rates is based on changes in the tipping fees at the Gold Coast Recycling and Transfer Station and Agromin's Organics Recycling and Processing Facility.

Effective December 1, 2020, the residential solid waste rates will increase 2.53% (tip fee only) and the commercial solid waste rates will increase by 1.73% (tip fee only). Please be aware that the Solid Waste Franchise Agreement requires E.J. Harrison & Sons to provide a minimum of fifteen (15) days written notice of the new rates to all customers. Enclosed for your reference is a complete set of residential and commercial solid waste rates.

The City of Camarillo appreciates the successful effort your company has made to meet Agreement requirements. We look forward to your continued cooperation in providing state-of-the-art waste removal and diversion services to the City of Camarillo.

Generators not meeting Recycling potential or cleanliness requirements will be charged the rates shown on *Schedule II* below. Generators charged *Schedule II* rates for non-compliance are eligible for Unicycle rates (*Schedule I*) after three months of successful participation in the City-approved Recycling program.

Generators must generate a minimum of nine cubic yards of Solid Waste weekly to qualify for free Recycling Container(s) and *Schedule II* rates.

The rates established in *Schedule II* above include free Recycling Container(s) and service. Recycling Container(s) may not contain more than 10 percent contaminants (non-Recyclable Materials) as determined by the City. Generators unable to meet cleanliness requirement will be charged for Recycling Containers at the rate charged for Solid Waste Container(s). Generators charged for collection of Recycling Containers because of non-compliance with the cleanliness requirement are eligible for free Recycling when the cleanliness requirement is achieved for three consecutive months. Any Generator that (because of excessive weight) has a landfill charge that exceeds 40 percent of the monthly charge will be charged for the additional weight plus a 25 percent handling fee.

E.J. Harrison and Sons, Inc. have accepted the City's proposed Rate adjustment detailed in a letter sent to us dated April 30, 2020. We have selected Option 1 which is to defer the residential and commercial rate increases, retro 11 months of tip fees, waive 12 months' worth of CPI, and agree to an effective date of December 1, 2020. I have attached a spreadsheet that shows the calculation of the rate adjustment. The standard Monthly residential rate will increase 2.53% to \$34.02. The combined standard Monthly Commercial rate will increase 1.73% to \$209.45. I have also attached a rate comparison sheet that shows that the City's residential and commercial rates are at or below the average comparable rates for similar Services for the five largest cities in Ventura County as stated in Section 12.6. The City of Camarillo has reviewed your proposed request for an adjustment to the residential and commercial solid waste rates, pursuant to the conditions outlined in sections 12.3, 12.4 and 12.6 of Agreement No. 2014-59. The proposed increase in the solid waste rates is based on changes in the Consumer Price Index and increases in the tipping fees at the Gold Coast Recycling and Transfer Station and Agromin's Organics Recycling and Processing Facility.
